NOTICE OF APPROVAL

This Notice of Approval addresses the application of CSWR-Texas Utility Operating Company, LLC and Douglas Utility Company c/o Zieben Group, for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County. The Commission approves the following: (1) the sale and transfer of all facilities and certificated service areas held under Douglas Utility's certificates of convenience and necessity (CCN) numbers 11369 and 20527 to CSWR-Texas; (2) the cancellation of Douglas Utility's CCN numbers 11369 and 20527; (3) the amendment of CSWR-Texas' CCN numbers 13290 and 21120 to include the facilities and service areas previously included in Douglas Utility's CCN numbers 11369 and 20527; and (4) the amendment of CSWR-Texas' CCN numbers 13290 and 21120 to add 27.9 acres of uncertificated service area.

I. Findings of Fact

The Commission makes the following findings of fact.

Applicants

- Douglas Utility is a Texas corporation registered with the Texas secretary of state under filing number 18261200.
- Douglas Utility holds CCN numbers 11369 and 20527 which obligates it to provide retail
 water and sewer service in Harris County.
- Douglas Utility owns a public water system registered with the Texas Commission on Environmental Quality (TCEQ) as Fountainview Subdivision under public water system identification number 1010127.

- 4. Douglas Utility owns and operates a TCEQ-permitted sewer system, under wastewater discharge permit number WQ11200001, registered as Douglas Utility Fountainview.
- CSWR-Texas is a Texas limited liability company registered with the Texas secretary of state under file number 803367893.
- 6. CSWR-Texas holds CCN number 13290 which obligates it to provide retail water service in multiple counties.
- CSWR-Texas holds CCN number 21120 which obligates it to provide retail sewer service in multiple counties.
- 8. CSWR-Texas owns and operates multiple public water systems registered with the TCEQ and sewer systems permitted by the TCEQ.

Application

- 9. On October 31, 2022, the applicants filed the application at issue in this proceeding.
- 10. CSWR-Texas supplemented the application on November 17, 18, and 21, and December 2, 2022, and February 27 and March 3, 2023.
- 11. In the application, supplemented, the applicants seek approval of the following:
 - a. the sale and transfer of all facilities and certificated service areas held under
 Douglas Utility's CCN numbers 11369 and 20527 to CSWR-Texas;
 - b. the cancellation of Douglas Utility's CCN numbers 11369 and 20527;
 - c. the amendment of CSWR-Texas' CCN numbers 13290 and 21120 to include the facilities and service areas previously included in Douglas Utility's CCN numbers 11369 and 20527; and
 - d. the amendment of CSWR-Texas' CCN numbers 13290 and 21120 to add 27.9 acres of uncertificated service area.
- 12. The requested water service area and sewer service area subject to the transaction (the requested areas) are identical in acreage and boundaries.
- 13. The requested areas includes approximately 104.9 acres, comprised of:

- a. 77 acres of singly certificated service area under Douglas Utility's CCN numbers 11369 and 20527;
- b. 27.9 acres of uncertificated area adjacent to Douglas Utility's existing service area; and
- c. 472 water and sewer customer connections.
- 14. The requested areas are located approximately 5 miles southwest of downtown Humble, Texas and is generally bounded on the north by Sam Houston Parkway (Tollway); on the east by Lee Road; on the south by Aldine Bender Road (Farm-to-Market Road 525); and on the west by Crosswinds Drive.
- 15. In Order No. 2 filed on December 2, 2022, the ALJ found the application, as supplemented, administratively complete.

Notice

- On January 17, 2023, CSWR-Texas filed the affidavit of Aaron Silas, director of regulatory operations for CSWR-Texas, attesting that mailed notice was provided to all current customers of Douglas Utility, neighboring utilities, and affected parties on December 13, 2022. CSWR-Texas also filed a publisher's affidavit attesting that notice was published in the *Houston Chronicle*, a newspaper of general circulation in Harris County, on December 7 and 14, 2022.
- 17. In Order No. 3 filed on January 31, 2023, the ALJ found the notice sufficient.
- 18. On June 13, 2023, CSWR-Texas filed a second affidavit by Mr. Silas indicating there are no landowners owning tracts of land over 25 acres wholly or partly inside the requested CCN areas.

Evidentiary Record

- 19. In Order No. 5 filed on April, 10, 2023, the ALJ admitted the following evidence into the record:
 - a. the application, including confidential attachments, filed on October 31, 2022;

- b. CSWR-Texas' first supplement to the application, including highly sensitive supplemental attachment G, filed on November 17 and 18, 2022;
- c. CSWR-Texas' second supplement to the application, including confidential supplemental attachment J, filed on November 21, 2022;
- d. CSWR-Texas' third supplement to the application, including highly sensitive attachment G, filed on December 2, 2022;
- e. CSWR-Texas' fourth supplement to the application, including highly sensitive attachment G, filed on February 27, 2023;
- f. CSWR-Texas' fifth supplement to the application, including confidential supplemental attachment A-1, filed on March 3, 2023;
- g. Commission Staff's recommendation on administrative completeness filed on December 1, 2022;
- h. CSWR-Texas' affidavit of notice to current customers, neighboring utilities, and affected parties, including HS Exhibit B, filed on January 17, 2023;
- Commission Staff's recommendation on sufficiency of notice, filed on January 27, 2023; and
- j. Commission Staff's recommendation on the transaction, including confidential attachment FB-1, filed on March 6, 2023.
- 20. In Order No.15 filed on March 19, 2024, the ALJ admitted the following evidence into the record:
 - a. CSWR-Texas' response to Order No. 7 filed on June 13, 2023;
 - Commission Staff's recommendation on supplemental notice filed on June 29, 2023;
 - c. Notice of completed transaction filed on October 17, 2023;
 - d. Commission Staff's recommendation on sufficiency of closing documents filed on October 31, 2023;

- e. CSWR-Texas' signed consent form filed on February 1, 2024;
- f. Douglas Utility's signed consent form filed on February 9, 2024; and
- g. The final maps, certificates, and tariffs as attached to the supplemental joint motion to admit evidence and proposed notice of approval filed on March 1, 2024.

<u>Sale</u>

- 21. In Order No. 6 filed on April 13, 2023, the ALJ approved the sale and transaction to proceed and required applicants to file proof that the transaction had been completed and that customer deposits, if any, had been addressed.
- On October 17, 2023, CSWR-Texas filed notice that the sale had closed on July 26, 2023, and confirmed that there were no outstanding customer deposits that needed to be addressed.
- 23. In Order No. 10 filed on November 1, 2023, the ALJ found the closing documentation sufficient.

Purchaser's Compliance History

- 24. CSWR-Texas has not been under enforcement action by the Commission, TCEQ, Texas Health and Human Services, the Office of the Texas Attorney General, or the United States Environmental Protection Agency in the past five years for non-compliance with rules, orders, or state statutes.
- 25. The Commission's complaint records, which date back five years, show 12 complaints against CSWR-Texas.
- 26. CSWR-Texas does not have a history of continuing mismanagement or misuse of revenues as a utility service provider.
- 27. CSWR-Texas demonstrated a compliance history that is adequate for approval of this transaction.

Adequacy of Existing Service

- 28. The last TCEQ compliance investigation of the Fountainview Subdivision public water system was on August 13, 2021. The last TCEQ compliance investigation of the Douglas Utility Fountainview sewer system was on April 18, 2022.
- 29. The Fountainview Subdivision water system has one violation listed in the TCEQ database.
- 30. The Commission's complaint records, which date back five years, show six complaints against Douglas Utility.
- 31. CSWR-Texas plans to make upgrades, renovations, and repairs to the system to return the systems to compliance and to ensure that customers receive safe and reliable service.

Need for Additional Service

- 32. There is a continuing need for service because Douglas Utility is currently serving 472 customer connections in the requested areas.
- 33. This is an application to transfer existing facilities, customers, and service areas.
- 34. There is no evidence of specific requests for additional service within the requested areas.

Effect of Approving the Transaction

- 35. CSWR-Texas will be the sole certificated water utility and sewer utility of the requested areas.
- 36. CSWR-Texas will be required to provide continuous and adequate water and sewer service to current and future customers in the requested areas.
- 37. All retail public utilities in the proximate area were provided notice of the application, and no protests or adverse comments were filed.
- 38. There will be no effect on any other retail public utility providing service in the proximate area.

Ability to Serve: Managerial and Technical

- CSWR-Texas owns and operates numerous TCEQ-approved public water systems and TCEQ-permitted sewer systems.
- 40. CSWR-Texas employs or contracts with TCEQ-licensed water operators and sewer operators who will operate the water and sewer systems.

- 41. No additional construction is necessary for CSWR-Texas to provide service to the requested areas.
- 42. CSWR-Texas has the technical and managerial capability to provide adequate and continuous service to the requested areas.

Ability to Serve: Financial Ability and Stability

- 43. CSWR, LLC, the immediate parent company of CSWR-Texas, is capable, available, and willing to cover temporary cash shortages, and has a debt-to-equity ratio of less than one, satisfying the leverage test.
- 44. CSWR, LLC provided a written guarantee of coverage of temporary cash shortages and demonstrated that it has sufficient cash available to cover any projected operations and maintenance shortages in the first five years of operations after completion of the transaction and possesses the cash and leverage ability to pay for capital improvements and necessary equity investments, satisfying the operations test.
- 45. CSWR-Texas submitted documents demonstrating funds are available for the purchase of the system and facilities.
- 46. CSWR-Texas demonstrated the financial and managerial capability and stability to provide continuous and adequate service to the requested areas.

Financial Assurance

47. There is no need to require CSWR-Texas to provide a bond or other financial assurance to ensure continuous and adequate service.

Feasibility of Obtaining Service from Adjacent Retail Public Utility

- 48. Douglas Utility is currently providing water and sewer service to customers in the requested areas and has sufficient capacity.
- 49. Obtaining service from an adjacent retail public utility would likely increase costs to customers because new facilities would need to be constructed. At a minimum, an interconnect would need to be installed in order to connect to a neighboring retail public utility.
- 50. It is not feasible to obtain service from an adjacent retail public utility.

Regionalization or Consolidation

- 51. It will not be necessary for CSWR-Texas to construct a physically separate water system or sewer system to serve the requested areas.
- 52. Because the requested areas will not require construction of a physically separate water or sewer system, consideration of regionalization or consolidation with another retail public utility is not required.

Voluntary Valuation of Acquired Utility or Facilities

- 53. Prior to filing the application, CSWR-Texas and Douglas Utility filed a notice to the Commission in Project No. 49859¹ of their intent to use the Commission's fair market value (FMV) process to determine the ratemaking rate base of Douglas Utility's water and sewer system assets to be acquired by CSWR-Texas.
- 54. CSWR-Texas included copies of the three appraisal reports required by the FMV process with the application and evidence of the purchase price agreed upon between CSWR-Texas and Douglas Utility.
- 55. The agreed upon purchase price for the transaction and the appraisals reported by each of the utility experts and the resulting average amount is identified in confidential attachment FB-1 to Commission Staff's recommendation on the transaction.
- The average of the three appraisals yields a purchase price of less than the FMV of Douglas Utility's water and sewer systems; therefore, the ratemaking rate base for Douglas Utility's water and sewer system is the agreed upon purchase price for the transaction identified in attachment FB-1 to Commission Staff's recommendation.
- 57. The application included CSWR-Texas' known and estimated transaction and closing costs.
- 58. No additional conditions for the acquisition based on the FMV process are needed.

Environmental Integrity and Effect on the Land

59. There will be minimal effects on environmental integrity and on the land as a result of CSWR-Texas' planned upgrades, renovations, and repairs to the water system and sewer system.

Improvement in Service or Lowering Cost to Consumers

- 60. Reliability and quality of water and sewer service is expected to improve under CSWR-Texas' management.
- The rates charged to customers in the requested area will not change as a result of the proposed transaction, because CSWR-Texas will adopt the currently in effect tariffs for the water system and sewer system upon approval of the transaction.

Maps, Certificates and Tariffs

- 62. On January 16, 2024, Commission Staff emailed the applicants the final proposed maps, certificates, and tariffs.
- 63. On February 1, 2024, CSWR-Texas filed its consent to the proposed final maps, certificates, and tariffs.
- 64. On February 2, 2024, Commission Staff emailed to CSWR-Texas revised water and sewer certificates and tariff pages relevant to this docket.
- 65. On February 9, 2024, CSWR-Texas, on behalf of Douglas Utility, filed Douglas Utility's consent to the proposed final maps, certificates, and tariffs.
- 66. On March 1, 2024, the parties filed the proposed final maps, certificates, and tariffs as attachments to the supplemental joint motion to admit evidence and proposed notice of approval.

Informal Disposition

- 67. More than 15 days have passed since the completion of notice provided in this docket.
- 68. No person filed a protest or motion to intervene.
- 69. CSWR-Texas, Douglas Utility, and Commission Staff are the only parties to this proceeding.
- 70. No party requested a hearing and no hearing is needed.

- 71. Commission Staff recommended approval of the application.
- 72. This decision is not adverse to any party.

II. Conclusions of Law

The Commission makes the following conclusions of law.

- 1. The Commission has authority over this proceeding under Texas Water Code (TWC) §§ 13.241, 13.242, 13.244, 13.246, 13.251, and 13.301.
- Douglas Utility and CSWR-Texas are retail public utilities as defined by TWC § 13.002(19) and 16 Texas Administrative Code (TAC) § 24.3(31).
- 3. The Commission processed the application as required by the TWC, the Administrative Procedure Act,² and Commission rules.
- 4. The application meets the requirements of TWC § 13.244 and 16 TAC §§ 24.233 and 24.239.
- 5. CSWR-Texas and Douglas Utility, provided notice of the application that complies with TWC §§ 13.246 and 13.301(a)(2) and 16 TAC § 24.239(a)-(c).³
- Douglas Utility and CSWR-Texas have complied with the requirements of 16 TAC § 24.239(k) and (I) with respect to customer deposits.
- 7. Douglas Utility and CSWR-Texas completed the sale within the time frame required by 16 TAC § 24.239(m).
- 8. After consideration of the factors in TWC § 13.246(c), CSWR-Texas demonstrated that it is capable of rendering continuous service to every customer in the requested areas, as required by TWC § 13.251.
- CSWR-Texas demonstrated adequate financial, managerial, and technical capability for providing adequate and continuous service to the requested areas as required by TWC §§ 13.241(a) and 13.301(b).

- 10. It is not necessary for CSWR-Texas to provide bond or other financial assurance under TWC §§ 13.246(d) and 13.301(c).
- 11. Regionalization and consolidation concerns under TWC § 13.241(d) do not apply in this proceeding because construction of a physically separate sewer system is not required.
- 12. CSWR-Texas and Douglas Utility demonstrated that the sale of Douglas Utility's water and sewer facilities and the transfer of the water and sewer service areas held under water CCN number 11369 and sewer CCN number 20527 from Douglas Utility to CSWR-Texas under water CCN number 13290 and sewer CCN number 21120 will serve the public interest and is necessary for the service, accommodation, convenience, or safety of the public under TWC § 13.301(d) and (e).
- The Commission's executive director selected three utility valuation experts to perform appraisal of Douglas Utility in compliance with TWC § 13.305(c)(2) and 16 TAC § 24.238(e).
- 14. The application included copies of the three appraisal reports completed by the utility valuation experts as required by TWC § 13.305(h) and 16 TAC § 24.239(d)(1)(A).
- 15. The application included the purchase price agreed to by CSWR-Texas and Douglas Utility as required by TWC § 13.305(h)(2) and 16 TAC § 24.239(d)(1)(B).
- 16. The application included the ratemaking rate based determined under TWC § 13.305(g) and 16 TAC § 24.238 as required by TWC § 13.305(h)(3).
- The application included the known transaction and closing costs incurred by CSWR-Texas to be requested for review for inclusion in CSWR-Texas' rate base and recovery in a future rate case as permitted by TWC § 13.305(e) and 16 TAC §§ 24.238(k), 24.239(d)(1)(C), and 24.239(d)(2).
- 18. The calculation of the fair market valuation for Douglas Utility complies with TWC § 13.305(f) and 16 TAC § 24.238(f)-(j).
- 19. The calculation of the ratemaking rate base for Douglas Utility complies with TWC § 13.305(g) and 16 TAC § 24.238(b)(3) and (4).

- 20. Under TWC § 13.257(r) and (s), CSWR-Texas must record a certified copy of the certificate and the map approved by this Notice of Approval, along with a boundary description of the service areas, in the real property records of Harris County within 31 days of receiving this Notice of Approval and submit to the Commission evidence of the recording.
- 21. The requirements for informal disposition under 16 TAC § 22.35 have been met in this proceeding.

III. Ordering Paragraphs

In accordance with these findings of fact and conclusions of law, the Commission issues the following orders.

- The Commission approves the sale and transfer of facilities, customers, and service areas held under Douglas Utility's CCN numbers 11369 and 20527 to CSWR-Texas' CCN numbers 13290 and 21120, to the extent provided in this Notice of Approval and as shown on the attached maps.
- 2. The Commission cancels Douglas Utility's CCN numbers 11369 and number 20527.
- The Commission amends CSWR-Texas' CCN numbers 13290 and 21120 to include the facilities, customers, and service areas previously included in Douglas Utility's CCN numbers 11369 and 20527, as shown on the attached maps.
- The Commission amends CSWR-Texas' CCN numbers 13290 and 21120 to add 27.9 acres of uncertificated area, as shown on the attached maps.
- 5. The Commission issues the certificates attached to this Notice of Approval.
- 6. The Commission approves the maps and tariffs attached to the Notice of Approval.
- 7. CSWR-Texas must provide service to every customer or applicant for service within the approved area under CCN 13290 and CCN number 21120 that requests service and meets the terms of CSWR-Texas' water and sewer service policies, and such service must be continuous and adequate.
- 8. CSWR-Texas must comply with the recording requirements in TWC § 13.257(r) and (s) for the area in Harris County affected by the application and must submit to the

Commission evidence of the recording no later than 45 days after receipt of the Notice of Approval.

- 9. Within ten days of the date this Notice of Approval is filed, Commission Staff must provide the Commission with a clean copy of the most current comprehensive tariffs, including the tariff pages approved by this Notice of Approval, to be stamped Approved and retained by Central Records.
- 10. The Commission denies all other motions and any other requests for general or specific relief, if not expressly granted.




