BOIL WATER NOTICE

Boil Your Water Before Drinking or Food Preparation to Avoid Illness

10/09/2023 – Due to a loss of water pressure in some zones, the State Water Resources Control Board, Division of Drinking Water, the Santa Cruz County Health Department, and the Big Basin Water Company are advising residents of the community utilizing Big Basin Water to only use boiled tap water or bottled water for drinking and cooking purposes as a safety precaution to avoid stomach or intestinal illness. The affected area includes: Melissa Ln, Kings Hwy, Rosita Dr, Dogwood Way, and Memory Ln.

We will inform you when tests show that water is safe to drink, and you no longer need to boil your water. We hope to have this problem resolved within 7 – 10 days.

Optional: Potable water is available at the following location: **SLV water station next to the drug store in Boulder Creek.**

Please bring a clean water container (5 gallons maximum capacity).

Do not drink the water without boiling it first

- Boil all water for one (1) minute (rolling boil).
- Let water cool before drinking.
- Use boiled or bottled water for drinking, brushing teeth, and food preparation until further notice.
- Boiling water kills bacteria and other organisms in the water.

If you are unable to boil your water:

Household unscented liquid bleach

- For clear water, use 8 drops (1/8 tsp.) of bleach for 1 gallon of water. For cloudy water, filter through a clean cloth and use 16 drops (1/4 tsp.) of bleach for 1 gallon of water.
- Mix well. Allow to stand for 30 minutes before using.
- Water may taste or smell like chlorine. This means disinfection has occurred.

Water disinfection tablets

- Please follow the manufacturer's instructions.
