Maximum Contaminant Level Violation, Average/Gross Alpha, Excluding Radon & Uranium Q4 (10/1/2023-12/31/2023)

The Texas Commission on Environmental Quality (TCEQ) has notified the SOUTH COUNCIL CREEK 2 TX02 70080 that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for gross alpha excluding radon and uranium. The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL for gross alpha excluding radon and uranium to be 15 pico curies per liter (pCi/L) based on running annual average (RAA) and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for gross alpha excluding radon and uranium indicates a compliance value in quarter four 2023 of 83 pCi/L for EP00L

This is not an emergency; certain minerals are radioactive and may emit a form of radiation known as alpha radiation. Some people who drink water containing alpha emitters in excess of the MCL over many years may have an increased risk of getting cancer.

You do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you.

**We are taking the following actions to address this issue:**

CSWR-Texas is actively exploring solutions to address the current water supply challenges, considering options such as implementing advanced ion exchange filters or developing new wells to ensure a reliable water source. We are closely monitoring the situation and will provide timely updates as we progress. Your well-being and access to clean water remain our top priority.

Maximum Contaminant Level Violation, Average/Combined Radium (226 & 228) Q4 (10/1/2023-12/31/2023)

The Texas Commission on Environmental Quality (TCEQ) has notified the SOUTH COUNCIL CREEK 2 TX0270080 that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for combined radium (-226 & -228). The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL for combined radium (-226 & -228) to be 5 pico curies per liter (pCi/L) based on running annual average (RAA), and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for combined radium (-226 & -228) indicates a compliance value in quarter four 2023 of 46 pCi/L for EPOOL

This is not an emergency. However, some people who drink water containing radium 226 and/or 228 in excess of the MCL over many years may have an increased risk of getting cancer.

You do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you.
