## SOAH ORDER NO. 12 APPROVING INTERIM RATES AND ADOPTING PROCEDURAL SCHEDULE

## I. APPROVING INTERIM RATES

On September 20, 2021 and October 20, 2021, Blue Cereus filed a motion for interim rates pursuant to 16 Texas Administrative Code (TAC) § 24.37. On October 29, 2021, the State Office of Administrative Hearings (SOAH) administrative law judge (ALJ) convened a prehearing conference in which Blue Cereus, Seguro Water Company (Seguro) and San Pedro Water Resources, JV (collectively, Wholesalers), and the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, the Parties) discussed an agreement on Blue Cereus's request for interim rates.

However, the parties were unable to finalize an agreement regarding one component of the interim rates. Blue Cereus contended that it could not in fact pay the approved \$2500/month wholesale water rates for the San Pedro system. On November 12, 2021, the ALJ convened a prehearing conference. At this prehearing conference, the ALJ directed the Parties to file information regarding (1) the amount Blue Cereus could afford to pay to the Wholesalers for purchased water for the San Pedro water system; and (2) the amount the Wholesalers needed to provide purchased water to the San Pedro water system.

Blue Cereus filed its 1<sup>st</sup> Amended Report on Interim Rates for San Pedro Village Water System<sup>2</sup> on November 19, 2021. In this report Blue Cereus argued that it could not afford to pay

more than \$1800 per month in purchased water costs to the Wholesalers for the San Pedro water system.<sup>3</sup> Blue Cereus also provided three attachments to support its claim that it cannot afford to pay more than \$1800 per month.

The Wholesalers filed a response on November 23, 2021, arguing that Blue Cereus had not met its burden to show that it could not pay the approved \$2500/month wholesale water rate for the San Pedro water system. The Wholesalers urged that the rate be set at \$2056-\$2446/month, based on the \$1774/month flat fee that the Temporary Manager had been paying the San Pedro water system and the \$6/connection/month fee he had been paying himself out of the \$20/connection/month fee from the final emergency rate set by the Commission. The Wholesalers also noted that Blued Cereus had initially agreed to a \$2500 rate, then a \$2000 rate, before asserting that a \$1800 rate was necessary, and that it should be held to its agreements. Staff filed a response on November 29, 2021, also arguing that Blue Cereus's evidence was insufficient to support a lesser interim rate and recommending that the rate be set using the lower of the Wholesalers' figures.

Based on the evidence submitted and the Parties' filings, the ALJ agrees that Blue Cereus has failed to support its request for an \$1800/month wholesale water rate for the San Pedro water system. The ALJ finds that a \$2056 monthly rate is appropriate. Accordingly, the ALJ adopts the Parties' previously submitted proposed agreed order, with the \$2056/month contested rate imposed for the San Pedro water system, as set forth below:

Blue Cereus's current approved rates are comprised of the rates listed in its approved tariffs plus an additional final emergency rate of \$20 per connection per month.<sup>5</sup> The additional \$20 per

connection per month was required to be allocated as follows: \$6 per connection per month was to be used to compensate the temporary manager; and \$14 per connection per month was to be used as needed for operational expenses that exceed revenues collected from base rates.<sup>6</sup> The Parties agreed to an interim rate that is identical to the current approved rate except that Blue Cereus may use the entirety of the additional \$20 per connection per month as necessary to operate and maintain the water system and to compensate the Wholesalers.

The ALJ finds that the agreed interim rates are just and reasonable and will continue to provide Blue Cereus with needed revenue while minimally impacting customers. Accordingly, the agreed interim rates are hereby **ADOPTED**, effective with the first billing cycle following the date of this order. The interim rates will remain in effect until a final rate determination is made or another interim rate is established and will be subject to refund or surcharge. The "relate back" date for the purposes of calculating the refund or surcharge is May 9. 2021. Blue Cereus **SHALL** provide notice to its customers of the interim rates in compliance with 16 TAC § 24.37(j) and **SHALL** file proof of notice in the docket no later than December 31, 2021.

The Parties further agreed that Blue Cereus will comply with 16 TAC § 24.43(c) when calculating customer bills using these interim rates. Accordingly, it is ordered that Blue Cereus **SHALL** round up or down to the nearest 1,000 gallons, as appropriate, or calculate the fractional portion of usage in its billing to customers for volumetric charges.

Lastly, Blue Cereus and the Wholesalers are currently negotiating the terms of a wholesale water contract. The Parties agreed that Blue Cereus will pay Seguro \$3,400 per month (\$2,000 by the 3<sup>rd</sup>, and \$1,400 by the 14<sup>th</sup>, or the next banking day if the 3<sup>rd</sup> or the 14<sup>th</sup> falls on a non-banking day) for wholesale water purchased to serve the customers of the La Caleta Estates Water System. Blue Cereus **SHALL** pay San Pedro Water Resources, JV \$2,056 per month (\$1,500 by the 3<sup>rd</sup>, and \$556 by the 14<sup>th</sup>, or the next banking day if the 3<sup>rd</sup> or the 14<sup>th</sup> falls on a non-banking day) for wholesale water purchased to serve the customers of the San Pedro Village Water System.

Therefore, it is ordered that the payment amounts will remain in effect until Blue Cereus and the Wholesalers are able to execute a written wholesale purchased water contracts.

It is further **ORDERED** that the following actions shall be taken **no later than April 11, 2022**, each party shall:

• file a witness list identifying and providing contact information for all witnesses the party expects to call to testify during the hearing;

• identify its witnesses, if any, for whom the other party waived cross-examination;

• file a list of all exhibits it intends to offer at the hearing (including, for example, on cross-examination);

• deliver to the ALJ at SOAH Room 504, 5<sup>th</sup> Floor, William P. Clements Building, 300 West 15<sup>th</sup> Street, Austin, Texas, 78701, *the ALJ's copies, the record copy, and two appeal copies* of all exhibits the party intends to offer. If a court reporter will transcribe the hearing, the parties SHALL, after consulting the court reporter about how to do so, provide *the record copy* instead to the court reporter, along with a copy of the party's witness list and exhibit list.<sup>7</sup>

All exhibits SHALL be marked with the offering party's name and the exhibit number. Exhibits should be numbered sequentially, and multipage documents shall be paginated or Bates-stamped. Exhibits not meeting a requirement in this order may not be admitted into the record absent good cause.

Prior to the hearing, the parties SHALL provide to witnesses all documents necessary for their effective participation in the hearing. Parties should also speak to the witnesses they intend to call to testify and provide them the necessary videoconferencing information.
